Sponsorship Program

Thank you for expressing an interest in becoming a sponsor for one of the ReVive girls. The Portuguese word for a 'sponsor' (padrinho (male) or madrinha (female)) is what we would call a 'God-Mother/Father' in English and I think this sums up precisely what we'd like a sponsor to be; someone who prays for the girl and, as far as possible, plays some part in their life.

If you join up to the program you will be sent information about the girl which you are sponsoring along with a picture. You will also receive letters from her (around once a quarter) and we'd also hope that you would also send her a few letters (or even emails via ReVive) and at least a birthday/Christmas card. You're also more than welcome to send a small present on special occasions. Monetary gifts are accepted but these will go towards gifts/trips for all of the girls - just to avoid one or two girls always receiving more than the others due to super generous sponsors.

She will know that you're sponsoring her and it'd be great if you could send a photo so she can also get to know you and pray for you as well. We'll keep you up to date with her progress - and don't worry about the language barrier - we can translate all correspondence.

Anyone can become a sponsor - an individual, a couple or even a home/small group. We ask for a monthly donation of £30 (which can be gift aided if you're a UK tax payer) and this

goes towards the general cost of housing the girl in ReVive. If your sponsored girl needs some medical or dental treatment then your donation will go towards that along with purchasing school materials and equipment. We ask that you commit to a year in the sponsorship program. Once the year is up you can decide whether you would like to continue for another year or not.

We will of course notify you when the time comes for the girl to return to her family or a substitute family. When this happens you will be given the opportunity to sponsor another girl in ReVive. Unfortunately, we're unable to financially support a girl when she leaves ReVive but we will do our best to continue facilitate correspondence should you so wish.

Please indicate as well if you would like your donations to be gift aided and set up a standing order using the bank details below. Once that is done please send an email to andy@revive-international.org to receive information on your sponsored girl.
